2. Purpose of the processing for which the personal data are intended, legal basis for the processing and period for which the personal data will be stored

4. What data protection rights do you have?

You have the right to access (Art. 15 GDPR), rectification (Art. 16 GDPR), erasure of data (Art. 17 GDPR) or restriction of the processing of your stored personal data (Art. 18 GDPR) and a right to data portability (Art. 20 GDPR) in accordance with the prerequisites of data protection law.
